**GUIDELINES FOR USE OF CHILDREN'S FRESH AIR FARM  
SUMMER LEARNING PROGRAM**

June 30, 2020

The following are the current general guidelines for members and guests entering or using the Children's Fresh Air Farm for the Summer Learning Program. These general guidelines may be supplemented for other specific events or uses—for example, use of the pool and playground. All guidelines are intended to reduce the risk of COVID-19 exposure and transmission.

1. **Designated Purpose:** Bringing the SLP children to the Farm for fun days.
2. **Limited Number of Attendees:** The maximum number of student attendees to the Farm is 22 per day.
3. **Transportation of students:** Students will be transported to CFAF via STS.

**Bus rules:** Open windows, masks required, 1 child per seat, same seat round trip, sanitize hands as students get on the bus, have bus sanitized while students are at CFAF

*In the event of rain, the event would be cancelled.*

4. **Temperatures:** All students will be temperature checked.
5. **Requirements for Teachers and Students:**
  - a. **Obligations Prior to Arrival:** All participants (teachers and students) are expected to exercise precautions prior to arrival to reduce the risk of virus transmission. Parents will be required to answer the following questions to help ensure students do not have or have not been exposed to COVID-19. These precautions include, but are not limited to, the following:

- Teachers and Parents should answer the following questions before arriving:
  - Have I or has my child been in close contact with a confirmed case of COVID-19?
  - Am I or is my child experiencing a cough, shortness of breath or sore throat?
  - Have I or has my child experienced a loss of taste or smell?
  - Have I or has my child had a fever in the last 24 hours?
  - Was my or my child's recent temperature over 100.4 degrees Fahrenheit?

***If the answer to any of the above questions is "yes," the person should not come to the church or the CFAF.***

- Use the restroom before leaving home as restrooms may be limited.
  - Wash hands with warm water for at least 20 seconds before leaving home.
- b. Social Distancing: All teachers and students must maintain a consistent six-foot distance between persons.
- When students arrive at CFAF they will be separated into 4 groups: Two groups will go to the pool and two groups will participate in rotations outside.
  - Playground area will be limited to 6 children at one time with social distancing among the group.
  - Current IPC pool guidelines IPC will be enforced with the exception that students will be allowed to change (one at a time) in the pool house, then place all clothes in a plastic bag and set it on the pool deck.
- c. Masks: Every person over the age of two (2) must wear masks while on any church property, including the bus and the farm. Exception: masks are not required in the pool.
- d. Food: Only sack lunches are allowed, with no food or beverage being shared between participants. Beverages should be in individual containers (bottles, cans, etc.), labeled with the child's name. Proper hand sanitation should occur **prior** to eating and **after** eating.
- e. Hand washing: Use hand sanitizers and disinfecting wipes as made available, and wash hands with warm water and soap when using available restrooms.

Acknowledgement of Exposure Risk: All participants understand and acknowledge that COVID-19 is a public health risk that can result in serious illness or death and exposure can occur despite precautions taken. All members and guests using or entering church property or facilities including CFAF voluntarily assume all risk of exposure. **Parents of SLP participants will be required to sign a waiver that recognizes the risk associated with participation. Attendance of people 65 or older or others especially at risk is discouraged.**

6. **Additional Requests or Instructions of Clergy or Church Staff**: All members and guests are expected to follow any additional requests or instructions made by the clergy or church staff.

Because of the fluid nature of state and local requirements and recommendations relating to COVID-19, these guidelines are subject to change without notice. Any exception to the foregoing guidelines must be approved in advance by the church. Rooms or areas of the church properties available for meetings or gathering and any limitations on the number of attendees will be determined by church facilities management in consultation with the appropriate church oversight committee.
